1	Section 1. The sum of \$242,000, or so much	thereof as

and that no obligations are incurred in excess of the sum appropriated. Any part of this appropriation not obligated as of September 30, 1990, shall revert to the General Fund of the State.

Section 3. The Governor shall submit a report to the Legislature before September 15, 1990, which shall:

(1) provide for the full disclosure of the obligations incurred against the sum appropriated by Section 1, and indicate the status of these funds as of September 1, 1990; and
