

AN ACT

To appropriate the sum of \$242,000 from the General Fund of the State for the purpose of supplementing the funds for the Department of Transportation in Fiscal Year 1990, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE

1 Section 1. The sum of \$242,000, or so much thereof as
2 may be necessary, is hereby appropriated from the General
3 Fund of the State for the purpose of supplementing the funds
4 for the Department of Transportation in Fiscal Year 1990.

5 These funds shall be apportioned as follows:

6	(1) Payment for dry docking	\$78,271.00
7	(2) Shortfall of "All Risk"	
8	Coverage	3,102.00
9	(3) Travel for search and rescue	
10	training by U.S. Coast Guard	8,796.00
11	(4) Supplemental for dry docking	
12	of MS Micro Trader	\$151,831.00
13	TOTAL	\$242,000.00


14 Section 2. The sum appropriated by Section 1 shall be
15 allotted to and administered by the Governor, who shall be
16 responsible to the Legislature to ensure that these funds
17 are used only for the purpose specified in Section 1 of this
18 Act, and in accordance with the Financial Management Act,
19 and that no obligations are incurred in excess of the sum
20 appropriated. Any part of this appropriation not obligated
21 as of September 30, 1990, shall revert to the General Fund
22 of the State.

23 Section 3. The Governor shall submit a report to the
24 Legislature before September 15, 1990, which shall:


25 (1) provide for the full disclosure of the
26 obligations incurred against the sum appropriated by
27 Section 1, and indicate the status of these funds as
28 of September 1, 1990; and


(2) indicate the planned use, during the remainder of the fiscal year, of funds not obligated as of September 1, 1990, PROVIDED, however, that a supplemental report covering the actual use and obligation of the funds shall be submitted to the Legislature or an appropriate committee thereof within 20 days after the closing of the fiscal year.

Section 4. This Act shall take effect upon approval by the Governor, or upon its becoming law without such approval.
