Section 1. The sum of \$726,094, or so much thereof
as may be necessary, is hereby appropriated from the
General Fund of the State for the purpose of funding
additional operations costs of certain departments and
offices of the Executive Branch of the State of Chuuk and
to provide for funding of other urgent programs of the
State, in fiscal year 1991. The funds herein appropriated

Section 2. All funds appropriated by Section 1 shall be administered by and is allotted to the Governor, who shall be responsible to the Legislature for ensuring that these funds are used only for the purposes specified in Section 1, and in accordance with the State Financial

Management Act, and that no obligations are incurred in 1 excess of the sum appropriated. The sum in Item 9 under 2 Section 1 of this Act shall be used as partial payment of 3 the Cost of Living Allowance (COLA) for State employees 4 as required by TSL No. 5-58 and TSL No. 5-106. 5 authority of the allottee to obligate these funds herein 6 appropriated shall lapse as of September 30, 1991. 7 Section 3. The Governor shall submit a report to the 8 Legislature on or before April 15, 1991, which shall: 9 (1) provide for the full disclosure of the 10 obligations incurred against the sum appropriated 11 by Section 1, and indicate the status of these 12 funds as of April 1, 1991; and 13 (2) indicate the planned use, during the 14 remainder of the fiscal year of funds not obligated 15 as of April 1, 1991; PROVIDED, however, that a 16 supplemental report covering the actual use and 17 obligation of the fund shall be submitted to the 18 Legislature or an appropriate committee thereof 19 within 20 days after the closing of the fiscal year. 20 Section 4.
