

AN ACT

To appropriate the sum of \$726,094 from the General Fund of the State for the purpose of funding additional operational costs of certain departments and offices of the Executive Branch of the State of Chuuk Government and to provide for funding of other urgent programs of the State, in fiscal year 1991, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. The sum of \$726,094, or so much thereof
 2 as may be necessary, is hereby appropriated from the
 3 General Fund of the State for the purpose of funding
 4 additional operations costs of certain departments and
 5 offices of the Executive Branch of the State of Chuuk and
 6 to provide for funding of other urgent programs of the
 7 State, in fiscal year 1991. The funds herein appropriated
 8 shall be apportioned as follows:

9	1. Education	\$102,400;
10	2. Public Affairs	2,100;
11	3. Transportation	6,300;
12	4. TOCA Administration	6,980;
13	5. Referral Facility Operation	70,000;
14	6. Marine Resources	10,314;
15	7. Peace Corps Allowance	13,000;
16	8. Health Services	15,000; and
17	9. Cost of Living Allowance	500,000
18	TOTAL	\$726,094

19 Section 2. All funds appropriated by Section 1 shall
 20 be administered by and is allotted to the Governor, who
 21 shall be responsible to the Legislature for ensuring that
 22 these funds are used only for the purposes specified in
 23 Section 1, and in accordance with the State Financial


1 Management Act, and that no obligations are incurred in
 2 excess of the sum appropriated. The sum in Item 9 under
 3 Section 1 of this Act shall be used as partial payment of
 4 the Cost of Living Allowance (COLA) for State employees
 5 as required by TSL No. 5-58 and TSL No. 5-106. The
 6 authority of the allottee to obligate these funds herein
 7 appropriated shall lapse as of September 30, 1991.

8 Section 3. The Governor shall submit a report to the
 9 Legislature on or before April 15, 1991, which shall:


10 (1) provide for the full disclosure of the
 11 obligations incurred against the sum appropriated
 12 by Section 1, and indicate the status of these
 13 funds as of April 1, 1991; and

14 (2) indicate the planned use, during the
 15 remainder of the fiscal year of funds not obligated
 16 as of April 1, 1991; PROVIDED, however, that a
 17 supplemental report covering the actual use and
 18 obligation of the fund shall be submitted to the
 19 Legislature or an appropriate committee thereof
 20 within 20 days after the closing of the fiscal year.

21 Section 4. This Act shall take effect upon approval
 22 by the Governor, or upon its becoming law without such
 23 approval.
