To repeal Truk State haw No. 3-44, which created the Truk Maritime Authority, to transfer all functions, responsibilities and funds thereof to the State Department of Marine Resources, and for other purposes.

Section 1. Repeal. Truk State Law No. 3-44, and any amendments thereto, which pertains to the creation of the Truk Maritime Authority, is hereby repealed in its entirety.

Transfer. All functions, responsibilities, Section 2. powers and duties exercised by the Truk Maritime Authority pursuant to law on the effective date of this Act are hereby transferred to and be carried out by the Department of Marine Resources. All staff and employees of the Authority existing on the effective date of this Act shall become the staff and employees of the Department of Marine Resources. All funds, assets and other properties are now the funds, assets and properties of the Department, and all powers and authority exercised by the Authority pursuant to law for their expenditures and dispositions are hereby transferred to and shall be exercised by the Department. Authority employees hereby transferred to the Department whose services may not be needed shall not continue employment starting October 1, 1991; such employees, however, shall be given first hiring priority for any vacancies in the government where their qualifications could be utilized.

23 Section 3. Effective Date. This Act shall take effect
