## AN ACT

To appropriate the sum of \$108,900 from the General Fund of the State for the fiscal year ending September 30, 1991, for the purpose of funding the State Education Bilingual Program, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

- Section 1. The sum of \$108,900, or so much thereof
- 2 as may be necessary, is hereby appropriated from the General
- Fund of the State for the fiscal year ending September 30,
- 4 1991, for the purpose of funding the State Education
- 5 Bilingual Program.
- 6 Section 2. The sum appropriated by Section 1 shall
- 7 be allotted to and administered by the Governor who shall
- 8 be responsible to the Legislature for ensuring that these
- 9 funds are used only for the purpose specified in Section
- 10 1, and in accordance with the State Financial Management
- 11 Act, and that no obligations are incurred in excess of the
- 12 sum appropriated. Any part of this appropriation not
- 13 obligated as of September 30, 1991, shall revert to the
- 14 General Fund of the State.
- 15 Section 3. The Governor shall submit a report to the
- 16 Legislature before April 15, 1991, which shall:
- 1) provide for the full disclosure of the
- 18 obligations incurred against the sum appropriated
- by Section 1, and indicate the status of those funds
- 20 as of April 1, 1991; and
- 21 2) indicate the planned use, during the re-
- 22 mainder of the fiscal year, of funds not obligated
- as of April 1, 1991; PROVIDED, however, that a
