## AN ACT

To appropriate the sum of \$82,100.00 from the General Fund of the State for the fiscal year ending September 30, 1991, for the purpose of funding travel, the standing committees of the House of Representatives and Senate of the Chuuk State Legislature, and for the Office of the Governor, and for other purposes.

## BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1	Section 1. The sum of \$82,100.00, or so much there-
2	of as may be necessary, is hereby appropriated from the
3	General Fund of the State for the fiscal year ending
4	September 30, 1991, for the purpose of funding travel cost
5	of the House of Representatives and Senate Standing
6	Committees of the Chuuk State Legislature, for the Office
7	of the Governor of Chuuk, and supplementing salary and
8	shall be apportioned as follows:
9	1. Chuuk State Legislatures' Standing
10	Committees and Governor Travel Costs: \$79,000;
11	a. House Travel \$49,000;
12	b. Senate Travel \$20,000;
13	c. Governor \$10,000.
14	2. Salary Supplement for Sergeant-at-Arms,
15	Senate \$ 3,100
16	TOTAL \$82,100.00
17	Section 2. The sum appropriated by Section 1 shall
18	be allotted to and administered by the Speaker, President
19	and the Governor who shall be responsible to the
20	Legislature for ensuring that these funds are used only
21	for the purposes specified in Section 1, and in accordance
22	with the State Financial Management Act, and that no
23	obligations are incurred in excess of the sum appropriated.

Any part of this appropriation not obligated as 1 September 30, 1991, shall revert to the General Fund of 2 3 the State. 4 Section 3. The Speaker, President and the Governor submit their reports to the Legislature before 5 September 15, 1991, which shall: 6 7 (1) provide for the full disclosure of the obligations incurred against the sum appropriated by 8 Section 1, and indicate the status of these funds as 9 10 of September 1, 1991; and 11 (2) indicate the planned use, during the 12 remainder of the fiscal year, of funds not obligated 13 as of September 1, 1991; PROVIDED, however, that a supplemental report covering the actual use and 14 obligation of the funds shall be submitted to the 15 16 Legislature or an appropriate committee thereof within 20 days after the closing of the fiscal year. 17 18 Section 4.
