

AN ACT

Appropriating the sum of \$243,000 from the General Fund of the State for the fiscal year ending September 30, 1991, for the purpose of funding the purchase of urgently needed fuel for the Weno Power Plant, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. The sum of \$243,000, or so much
2 thereof as may be necessary is hereby appropriated from the
3 General Fund of the State for the fiscal year ending
4 September 30, 1991, for the purpose of funding the purchase
5 of fuel for the Weno Power Plant on Weno. The sum herein
6 is appropriated from the General Fund shall be used for
7 fuel for the Weno Power Plant up to August 31, 1991.

8 Section 2. The sum appropriated by Section 1
9 shall be administered by and is allotted to the Governor who
10 shall be responsible to the Legislature for ensuring that
11 these funds are used only for the purposes specified in
12 Section 1, and in accordance with the State Financial
13 Management Act, and that no obligations are incurred in
14 excess of the sum appropriated. The remainder of the funds
15 so appropriated hereunder shall revert to the General Fund
16 of the State by the end of this fiscal year.


17 Section 3. The Governor shall submit a
18 report to the Legislature before September 15, 1991, which
19 shall:

- 20 1) Provide for the full disclosure of the obligations
21 incurred against the sum appropriated by Section 1, and
22 indicate the status of the funds as of September 1, 1991;
23 and
24 2) Indicate the planned use during the remainder of
25 the fiscal year during the period beyond September 1, 1991,

1 of the funds not obligated as of September 1, 1991, provided
2 however that a supplemental report covering the actual use
3 and obligation of the funds shall be submitted to the
4 Legislature or an appropriate committee thereof within 20
5 days after the end of this fiscal year.


6 Section 4. This Act shall take effect upon
7 approval by the Governor, or upon its becoming law without
8 such approval.




