

AN ACT

to appropriate the sum of \$1,567,000.00 for the fiscal year ending September 30, 1991, for the purpose of supplementing certain operational costs of the Chuuk State Government for the remainder of the ensuing fiscal year, and for other purposes.

ENACTED BY THE CHUUK STATE LEGISLATURE:

Section 1. The sum of \$1,567,000.00 is appropriated from the General Fund of the State of Chuuk for the fiscal year ending September 30, 1991, for the purpose of supplementing certain operational costs of the Chuuk State Government for the remainder of the ensuing fiscal year.

This sum so appropriated shall be apportioned as follows:

(a) Fuel for Weno Power Plant	\$ 167,000.00
(b) Department of Transportation	\$ 100,000.00
(i) State vessels provisioning	\$ 75,000.00
(ii) State Airport (FY'91 CIP)	\$ 25,000.00
(c) Supplemental for salaries of employees of the State Government	\$1,300,000.00
TOTAL	\$1,567,000.00

Section 2. The sum appropriated by Section 1(a) and (b) shall be administered by and is allotted to the Governor and the sum appropriated by Section 1(c) shall be administered by the respective allottees as identified in the 1991 Budget Act (CSL No. 190-10) for each branch of government for program from which 8% had been decreed by the Governor. Each allottee shall be responsible to the Legislature for ensuring that these funds are used only for the purposes specified in Section 1, and in accordance with

the Financial Management Act, and that no obligations are incurred in excess of the sum appropriated. Any part of this appropriation not obligated as of September 30, 1991, shall revert to the General Fund of the State.


Section 3. Each allottee herein shall submit a report to the Legislature on or before September 30, 1991, which shall provide for the full disclosure of the obligations incurred against the sum appropriated by Section 1 and indicate the status of the funds as of the reporting date; PROVIDED, that a supplemental report covering the actual use and obligations of the funds shall be submitted to the Legislature, or an appropriate committee thereof, within 20 days after the closing of the fiscal year.

Section 4. This Act shall become law upon approval by the Governor, or upon its becoming law without such approval.
