AN ACT

To appropriate the sum of \$40,000 from the General Fund of the State for the fiscal year ending September 30, 1991, for the purpose of a State-wide goodwill game to be held in celebration of the Chuuk State Constitution, beginning on September 16, and ending on October 2, 1991, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1           Section 1. The sum of \$40,000, or so much thereof as  
2           may be necessary, is hereby appropriated from the General  
3           Fund of the State for the fiscal year ending September 30,  
4           1991, for the purpose of a State-wide goodwill game to be  
5           held in celebration of the Chuuk State Constitution,  
6           beginning on September 16, and ending on October 2, 1991.

7           The sum herein shall be apportioned as follows:

8	1) Transportation	\$18,000;
9	2) Logistical Support	8,000;
10	3) Prizes	12,000;
11	4) Equipment	1,000; and
12	5) Field Preparation	1,000.
13	Total	\$40,000

14           Section 2. The sum appropriated by Section 1 shall  
15           be administered by and is allotted to the Governor, who  
16           shall be responsible to the Legislature for ensuring that  
17           these funds are used only for the purposes specified in  
18           Section 1, and in accordance with the State Financial  
19           Management Act, and that no obligations are incurred in  
20           excess of the sum appropriated. Any part of this  
21           appropriation not obligated as of September 30, 1991,  
22           shall revert to the General Fund of the State.

23           Section 3. The Governor shall submit a report to the  
24           Legislature on or before September 30, 1991, which shall:

1           1) Provide for the full disclosure of the  
2 obligations incurred against the sum appropriated  
3 by Section 1, and indicate the status of the  
4 funds as of September 30, 1991; and


5           2) Indicate the planned use, during the  
6 remainder of the fiscal year, of funds not  
7 obligated as of September 30, 1991; PROVIDED, that  
8 a supplemental report covering the actual use and  
9 obligation of the funds shall be submitted to the  
10 Legislature, or an appropriate committee thereof,  
11 within 20 days after the expenditure of the funds.

12       Section 4. This Act shall take effect upon approval  
13 by the Governor, or upon its becoming law without such  
14 approval.
