AN ACT

To appropriate the sum of \$1,812,000 is appropriated from the General Fund of the State for the purpose of acquiring stocks in the Bank of the Redenated States of Micronesia and the Bank of Guam, and for other purposes.

BE IT ENACTED BY THE CHULK STATE LEGISLATURE:

- Section 1. The sum of \$1,812,000 is appropriated from
 the General Fund of the State for the purpose of acquiring
 stocks for Chuuk State in the Bank of the Federated States
 of Micronesia and the Bank of Guam. The sum indicated above
 shall be expended as follows:
- A) \$1,000,000 for the purchase of stocks at the
 Bank of the Federated States of Micronesia; and
 - B) \$812,000 for the purchase of stocks at the Bank of Guam.
 - Section 2. The sum appropriated by Section 1 shall be allotted to and administered by the Governor who shall be responsible to the Legislature for ensuring that these funds are used only for the purpose specified in Section 1, and in accordance with the State Financial Management Act, and that no obligations are incurred in excess of the sum appropriated.
- Section 3. The Director of Treasury shall be responsible for monitoring and provision of quarterly report to the Governor and the Legislature on the status of these investments.
- Section 4. The Governor shall submit a report to the
 Legislature no later than 30 days after the funds have been
 fully expended.
