

AN ACT

To appropriate the sum of \$75,000 from the General Fund of the State of Chuuk for the fiscal year ending September 30, 1993, for the purpose of defraying the costs of the inauguration of the Governor, the Lieutenant Governor and members of the Second Legislature of the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF CHUUK:

1 Section 1. The sum of \$75,000, or so much
2 thereof as may be necessary, is hereby appropriated from
3 the General Fund of the State of Chuuk for the fiscal year
4 ending September 30, 1993, for the purpose of defraying
5 the costs of the inauguration of the Governor, Lieutenant
6 Governor and members of the Second Legislature of the
7 State of Chuuk.

8 Section 2. All funds appropriated by this act
9 shall be allotted to the Governor who shall be responsible
10 to the Legislature for ensuring that these funds are used
11 solely for the purpose specified in Section 1 of this Act
12 and in accordance with the State Financial Management Act,
13 and that no obligations are incurred in excess of the sum
14 appropriated. The authority of the allottee to obligate
15 funds appropriated by this Act shall lapse as of September
16 30, 1993.

17 Section 3. The Governor shall submit a report
18 to the Legislature which shall:

- 19 1) provide for the full disclosure of the
- 20 obligations incurred against the sum appropriated by
- 21 Section 1 of this Act, and indicate the status of these
- 22 funds as of September 15, 1993; and


1 2) indicate the planned use, during the remainder of
2 the fiscal year, of funds not obligated as of September
3 15, 1993, PROVIDED, however, that a supplemental report
4 covering the actual expenditures of this funds shall be
5 submitted to the Legislatures of this funds shall be
6 submitted to the Legislature or an appropriate committee
7 thereof within 20 days after the end of the fiscal year.

8 Section 4. This Act shall take effect upon
9 approval by the Governor, or upon its becoming law without
10 such approval.
