- The Governor shall submit a report to the 15 Legislature on or before September 15, 1993, which shall: 16
- provide for the full disclosure of the 17 obligations incurred against the sum appropriated by 18 Section 1, and indicate the Status of the funds as of 19 September 15, 1993; and 20
- indicate the planned use, during the remainder 21 of the fiscal year, of funds not obligated as of 22 September 15, 1993; PROVIDE, that a supplemental report 23
