AN ACT

To appropriate the sum of \$234,000 from the General Fund of the State fiscal year ending September 30, 1993 for the purpose of funding the partial payment of the FEMA loan, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

- The sum of \$234,000, or so much thereof as Section 1. 2 may be for necessary, is hereby appropriated from the 3 General Fund of the State for the fiscal year ending 4 September 30, 1993 for the purpose of funding the partial payment of the FEMA loan. Section 2. The sum appropriated by Section 1 shall be
- 5 6 7 administered by and is allotted to the Governor, who shall 8 be responsible to the Legislature for ensuring that these funds are used only for the purpose specified in Section 1, 10 and in accordance with the State Financial Management Act, 11 and that no obligations are incurred against the 12 appropriate. Any part of this appropriation not obliquted as of September 30, 1993, shall remain available until fully 13 14 expended.
- Section 3. The Governor shall submit a report to the Legislature before September 15, 1993, which shall:
- 1) provide for the full disclosure of the

	of the fiscal year, of fund not obligated as of

	funds shall be submitted to the Legislature, or an
	appropriate committee thereof, within 20 days after the
	closing of the fiscal year.
	Section 4. This Act shall take effect upon approval by
	the Governor or upon its becoming law without such approval.
