The governor shall submit a report to the Legislature on or before September 30, 1993, which shall: Provide for the full disclosure of the 10 obligations incurred against the sum appropriated by 11 Section 1, and indicate the status of these funds as 12 of September 30, 1993; and 13 indicate the planned use, during the remainder 14 of the fiscal year, of funds not obligated as of 15 September 30, 1993, PROVIDED, that a supplemental 16 report covering the actual use and obligations of these funds shall be submitted to the Legislature or an appropriated committee thereof, within 20 days after the closing of the fiscal year.
