

AN ACT

To appropriate the sum of \$54,880, from the General Fund of the State for the fiscal year ending September 30, 1993, for the purpose of funding a State Leadership Conference on CIP, the selection of the Independent Prosecutor for Chuuk State and other important matters, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. The sum of \$54,880, or so much thereof as
2 may be necessary, is hereby appropriated from the General
3 Fund of the State for the fiscal year ending September 30,
4 1993, for the purpose of funding a State Leadership
5 conference on CIP, the selection of the Independent
6 Prosecutor for Chuuk State and other important matters. The
7 funds shall be allocated as follows:

- 8 1) Allowance for 120 Participants:
- 9 a) Outer-Island Participants
- 10 (72x\$50x8 days) ----- \$28,800;
- 11 b) Lagoon Participants
- 12 (48x\$50x5 days) ----- \$12,000;
- 13 Subtotal ----- \$40,800
- 14 2) Transportation (pick-up and drop-off
- 15 4 trips)----- \$10,080.
- 16 3) Printing, Reproduction and Supplies:
- 17 a) Reproduction & paper ----- \$3,000;
- 18 b) Other Supplies ----- \$1,000;
- 19 Subtotal ----- \$4,000
- 20 GRAND TOTAL ----- \$54,880

21 Section 2. The sum appropriated by Section 1 shall be
22 administered by and is allotted to the Governor, who shall
23 be responsible to the Legislature for ensuring that these


1 funds are used only for the purposes specified in Section 1,
2 and in accordance with the State Financial Management Act,
3 and that no obligations are incurred in excess of the sum
4 appropriated. Any part of this appropriation not obligated
5 as of September 30, 1993, shall revert to the General Fund
6 of the State.


7 Section 3. The governor shall submit a report to the
8 Legislature on or before September 30, 1993, which shall:

9 1) Provide for the full disclosure of the
10 obligations incurred against the sum appropriated by
11 Section 1, and indicate the status of these funds as
12 of September 30, 1993; and

13 3) indicate the planned use, during the remainder
14 of the fiscal year, of funds not obligated as of
15 September 30, 1993, PROVIDED, that a supplemental
16 report covering the actual use and obligations of these
17 funds shall be submitted to the Legislature or an
18 appropriated committee thereof, within 20 days after
19 the closing of the fiscal year.

20 Section 4. This Act shall take effect upon approval by
21 the Governor, or upon its becoming law without such
22 approval.






