AN ACT

To appropriate the sum of \$169,540 (\$24,540 from the inflationary adjustment on the Current Account, and \$145,000 from the inflationary adjustment on the Capital Account), from the General Fund of the State during the fiscal year ending September 30, 1993, for the purpose of funding a special election, to fill the five seats reserved for Election District No. 1, funding the State Scholarship Fund for School Year 1993-1994, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. a) The sum of \$24,540, or so much thereof as may be necessary, is hereby appropriated from the General Fund 2 3 the State for the fiscal year ending September 30, 1993, for the purpose of defraying the costs of holding a special election in Election District No. 1, to fill the vacancy which 5 exists in the House of Representatives as a result of the 6 7 House of Representatives not seating one of the elected 8 candidates for Election District No. The 1. sum, appropriated, shall come from the balance of 9 received as inflationary adjustment on the Current Account of 10

a) Election Board \$8,750

10 b) The sum of \$145,000, or so much thereof as may necessary, is hereby appropriated from the General Fund 11 of the State for the fiscal year ending September 30, 1993, 12 for the purpose of funding scholarship awards made by the 13 State Scholarship Board pursuant to the State Scholarship 14 15 Fund Act. The fund so appropriated shall come from the balance of the funds received as inflationary adjustment on 16 Capital Account of the General Fund, and shall not be used 17 for any operating costs or any related administrative costs 18 of the Office or the Board for the program pursuant to law. 19 The fund shall remain available until fully expended. 20

Section 2. The sum appropriated by Section 1(a) and (b) shall be administered by and are allotted to the Governor, who shall be responsible to the Legislature for ensuring that these funds are used only for the purposes specified in Section 1 and in accordance with the State Financial Management Act, and that no obligations are incurred in excess of the sum appropriated. Any part of these appropriations, except as provided in Section 1(b), not obligated as of September 30, 1994, shall revert to the General Fund of the State.

1	Section 3. The Governor shall submit a report to

4	1) Provide for the full disclosure of the
5	obligations incurred against the sums appropriated by
6	Section 1(a) and (b), and indicate the status of these
7	funds as of September 15, 1994; and
8	2) Indicate the planned use during the remainder
9	of the fiscal year, of these funds not obligated as of
10	September 15, 1994; PROVIDED, however, that a
11	supplemental report covering the actual use and
12	obligations of these funds shall be submitted to the
13	Legislature or an appropriate committee thereof within 20
14	days after the closing of the fiscal year.
15	Section 4. This Act shall take effect upon approval
16	by the Governor, or upon its becoming law without such
17	approval.
