

AN ACT

To appropriate the sum of \$169,540 (\$24,540 from the inflationary adjustment on the Current Account, and \$145,000 from the inflationary adjustment on the Capital Account), from the General Fund of the State during the fiscal year ending September 30, 1993, for the purpose of funding a special election, to fill the vacancy existing in the House of Representatives for one of the five seats reserved for Election District No. 1, funding the State Scholarship Fund for School Year 1993-1994, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. a) The sum of \$24,540, or so much thereof as
2 may be necessary, is hereby appropriated from the General Fund
3 of the State for the fiscal year ending September 30, 1993,
4 for the purpose of defraying the costs of holding a special
5 election in Election District No. 1, to fill the vacancy which
6 exists in the House of Representatives as a result of the
7 House of Representatives not seating one of the elected
8 candidates for Election District No. 1. The sum, so
9 appropriated, shall come from the balance of the funds
10 received as inflationary adjustment on the Current Account of
11 the General Fund, which shall be allocated as follows:

10 b) The sum of \$145,000, or so much thereof as may
11 be necessary, is hereby appropriated from the General Fund
12 of the State for the fiscal year ending September 30, 1993,
13 for the purpose of funding scholarship awards made by the
14 State Scholarship Board pursuant to the State Scholarship
15 Fund Act. The fund so appropriated shall come from the
16 balance of the funds received as inflationary adjustment on
17 Capital Account of the General Fund, and shall not be used
18 for any operating costs or any related administrative costs
19 of the Office or the Board for the program pursuant to law.
20 The fund shall remain available until fully expended.

21 Section 2. The sum appropriated by Section 1(a) and
22 (b) shall be administered by and are allotted to the
23 Governor, who shall be responsible to the Legislature for
24 ensuring that these funds are used only for the purposes
25 specified in Section 1 and in accordance with the State
26 Financial Management Act, and that no obligations are
27 incurred in excess of the sum appropriated. Any part of
28 these appropriations, except as provided in Section 1(b),
29 not obligated as of September 30, 1994, shall revert to the
30 General Fund of the State.


1 Section 3. The Governor shall submit a report to
2 the Legislature on or before September 30, 1994, which
3 shall:


4 1) Provide for the full disclosure of the
5 obligations incurred against the sums appropriated by
6 Section 1(a) and (b), and indicate the status of these
7 funds as of September 15, 1994; and

8 2) Indicate the planned use during the remainder
9 of the fiscal year, of these funds not obligated as of
10 September 15, 1994; PROVIDED, however, that a
11 supplemental report covering the actual use and
12 obligations of these funds shall be submitted to the
13 Legislature or an appropriate committee thereof within 20
14 days after the closing of the fiscal year.

15 Section 4. This Act shall take effect upon approval
16 by the Governor, or upon its becoming law without such
17 approval.






