

AN ACT

To appropriate the sum of \$200,000.00 from the General Fund of the State for the fiscal year ending September 30, 1997, for the purpose of funding the General Election and any resulting runoff election of the State, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

Section 1. The sum of \$200,000.00, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the State for the fiscal year ending September 30, 1997, for the purpose of funding the General Election and any resulting runoff election of the State. These funds shall be apportioned as follows:

1) Personnel Services.....	\$48,900.00
2) Equipment, Supplies & Materials.....	\$15,417.05
3) Transportation and Travel.....	\$38,018.75
4) Reproduction & Printing.....	\$ 9,997.40
5) POL (Petroleum, Oil & Lubricants).....	\$ 2,457.00
6) Others.....	\$13,209.80
Total.....	\$128,000.00

Section 2. The remainder of the \$200,000.00 herein appropriated, (\$72,000.00) shall be applied exclusively toward the cost of any resulting runoff election. If no runoff election is necessary, the \$72,000.00 shall revert immediately to the General Treasury.

Section 3. The sum appropriated by Section 1 shall be administered by and is allotted to the Election Commission, who shall be responsible to the Legislature for ensuring that these funds are used in strict compliance with the budget work-sheets, only for the purposes specified in Sections 1 and 2, and in accordance with the State Financial Management Act, and that no obligations are incurred in excess of the sum

1 appropriated. Any part of this appropriation not obligated as
2 of September 30, 1997, shall revert to the General Fund of the
3 State.

4 Section 4. The Election Commission shall submit a
5 report to the Legislature on or before July 15, 1997, which
6 shall:

7 1) Provide for the full disclosure of the
8 obligations incurred against the sum appropriated by
9 Sections 1 and 2, and indicate the status of the funds as
10 of July 1, 1997; and


11 2) Indicate the planned use, during the remainder
12 of the fiscal year, of funds not obligated as of July 1,
13 1997; PROVIDED, that a supplemental report covering the
14 actual use and obligation of the funds shall be submitted
15 to the Legislature, or an appropriate committee thereof,
16 within 20 days after the closing of the fiscal year.

17 Section 5. This Act shall take effect upon approval by
18 the Governor, or upon its becoming law without such approval.
