

AN ACT

To appropriate the sum of \$903,687.00 from the General Fund of the State for the fiscal year ending September 30, 1997 for the purpose of funding the School Improvement Project in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. a) The sum of \$903,687.00, or so much thereof as may be necessary,
2 is hereby appropriated from the General Fund of the State for the School Improvement
3 Project in the State of Chuuk. The funds shall be appropriated as follows:

4	1. Personnel	142,057.00
5	2. Fringe Benefits	11,030.00 ~
6	3. Travel	28,636.00 ~
7	4. Equipment	65,200.00 ✓
8	5. Supplies	326,700.00
9	6. Contractual Services	160,100.00
10	7. Other	113,410.00
11	8. Indirect Cost	56,554.00
12	Total	903,687.00

13 b) The funds, upon being allotted to the State, shall be deposited by the Director
14 of Treasury into a Special Account of the General Fund of the State, to allow
15 continuity and to prevent interruption in the use of the fund due to the cash
16 flow problem.

17 c) Upon the approval of this act, the operation of the Program including the
18 hiring and transfer of needed personnel shall not commence until the actual
19 receipt of the above funds by the State.

20 Section 2. The sum appropriated by Section 1 shall be administered by and is
21 allotted to the Governor, who shall be responsible to the Legislature for ensuring that

1 these funds are used only for the purposes specified in Section 1, and in accordance with
2 the State Financial Management Act, and that no obligations are incurred in excess of the
3 sum appropriated. Any part of this appropriation not obligated as of September 30, 1997,
4 shall remain available until fully expended.


5 Section 3. The Governor shall submit a report to the Legislature on or before
6 September 15, 1997, which shall:

- 7 1) provide for the full disclosure of the obligations incurred against the
8 sum appropriated by Section 1, and indicate the status of the funds as
9 of September 1, 1997; and
10 2) indicate the planned use, during the remainder of fiscal year 1997, of
11 funds not obligated as of September 1, 1997; PROVIDED, that a
12 supplemental report covering the actual use and obligation of the funds
13 shall be submitted to the Legislature, or an appropriate committee
14 thereof, within 20 days after the closing of the fiscal year.


15 Section 4. This Act shall take effect upon approval by the Governor, or upon its
16 becoming law without such approval.


