AN ACT

To appropriate the sum of \$213,945.00 from the General Fund of the State of Chuuk for the fiscal year ending September 30, 1998, for the purpose of supplementing the Chuuk State matching funds for the U.S. Department of Commerce, Economic Development Administration, water project for Weno; to repeal CSL No. 2-93-05, section 1(10) and section 1(12), TSL No. 6-12, section 1(B)(5) and TSL No. 6-89, section 1(B)(3); and for

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

Section 1. Introduction. In response to the water problem on Weno, the State of 1 Chuuk has applied for a grant from the U.S. Department of Commerce, Economic 2 Development Administration, hereinafter referred to as the "EDA", for a Weno Water 3 System. The EDA conditionally extended to the State of Chuuk a grant in the amount of 4 \$1,621,750.00 pursuant to EDA Award No. 07-01-03430. The condition being that EDA 5 shall pay 65 percent, the amount of which was awarded by EDA, and the State of Chuuk 6 shall pay the remaining 35 percent of the costs of the project, an equivalent of 7 \$873,250.00. Chuuk State's matching funds are obtained from \$659,305.00 previously 8 appropriated by CSL No. 193-08 and CSL No. 2-93-05. A total sum of \$126,169.00 is 9 still available in the FSM Treasury as unexpended funds from previously completed water 10 projects, and needs to be reappropriated for this project. The remaining balance of 11 \$87,776.00 shall be appropriated from FY'98 CIP funds. Chuuk State is still short by 12 \$213,945.00. 13 Section 2. Appropriation. There is hereby appropriated from the General Fund of 14 the State of Chuuk the sum of \$213,945.00 for the fiscal year ending September 30, 1998,

for the purpose of supplementing the matching funds already appropriated and

contributed by the State of Chuuk to the Weno Water System Project, awarded by EDA to

appropriated hereby. Any funds that are not obligated on or before September 30, 1998, 1 shall revert to the Chuuk State General Funds. 2 Section 4. Repeal. With respect to unexpended funds, those appropriations as 3 provided for in the following laws are hereby repealed: CSL No. 2-93-05, section 1(10) 4 and section 1(12); TSL No. 6-12, section 1(B) (5); and TSL No. 6-89, section 1(B)(3). 5 Section 5. Report. The allottee of the funds appropriated pursuant to section 2 of 6 this act shall submit his written report to the Legislature within 90 days from the end of Fiscal Year 1998. Such report shall include but need not be limited to detailed expenditure of the funds. Section 6. Effective Date. This act shall become law upon approval by the Governor or upon its otherwise becoming law without such approval.
