

AN ACT

To appropriate the sum of \$100,000 from the General Fund of the State of Chuuk for the fiscal year ending September 30, 1998, for the purpose of funding the improvement of the dump site area on Weno, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. Introduction. (a) In January of 1998, a proclamation was jointly and
 2 severally executed by the Governor of Chuuk, the President of the Senate, and the
 3 Speaker of the House of Representatives of the Chuuk State Legislature, proclaiming
 4 1998 as the "Reconstruction Year", pursuant to which it was decreed that the residents of
 5 Chuuk State, citizens and non-citizens alike, join hands:

6 "..... (2) to reconstruct, maintain, and promote the scenic beauty,
 7 cleanliness, and the serenity of our isles of paradise to make our own lives comfortable
 8 and the lives of our visitors enjoyable and pleasant;..."

9 (b) One of the impediments which stands in the way of keeping Weno clean,
 10 beautiful, and as health hazard free as possible is the lack of a dump site into which all
 11 the garbage and waste materials shall be disposed. This act shall take care of that
 12 deficiency.

13 Section 2. Appropriation. There is hereby appropriated the sum of \$100,000
 14 from the General Fund of the State of Chuuk for the fiscal year ending September 30,
 15 1998, for purpose of funding the improvement of the dump site located at Neauo, Weno
 16 Municipality. The funds shall come from 1998 CIP account.

17 Section 3. Use of the Funds. (a) The funds appropriated by section 2 of this act
 18 shall be used for the following:



3 Section 4. Allottee. The Governor of Chuuk shall be the allottee of the funds
4 appropriated pursuant to section 2 of this act. The funds so appropriated by section 2
5 hereof shall be administered and accounted for in accordance with the Chuuk State
6 Financial Management Act of 1982. Any funds not obligated on or before September 30,
7 1998, shall automatically revert to the General Fund.


8 Section 5. Reporting. The allottee shall submit a report of the use of the funds no
9 later than April 30, 1999. The report required by this section shall set forth the specific
10 and detailed use of the funds.


11 Section 6. Effective Date. This act shall become law upon approval by the
12 Governor or upon its otherwise becoming law without such approval.
