

AN ACT

To appropriate the sum of \$125,000 from the General Fund of the State of Chuuk for the fiscal year ending September 30, 1998, for the purpose of funding Chuuk State participants in the Micronesian Games, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. Appropriation. There is hereby appropriated the sum of \$125,000
 2 from the General Fund of the State of Chuuk for the fiscal year ending September 30,
 3 1998, not otherwise appropriated, for the purpose of funding Chuuk State participants
 4 during the upcoming Micronesian Games to be held in Palau in August, 1998. The funds,
 5 to be appropriated from Compact investment earnings, shall be apportioned as follows:

6	1) Off and On Island Coaching Assistance	\$ 5,795.00
7	2) Preparatory Training Camps	\$ 10,000.00
8	3) Special Training or Team Equip.	\$ 5,000.00
9	4) Uniforms and Team Clothing	\$ 25,000.00
10	5) Per Diem and Departure Fees	\$ 28,055.00
11	6) Transportation in Palau	\$ 4,000.00
12	7) Goodwill Gifts	\$ 4,000.00
13	8) Supplement for Travel Funds	\$ 16,000.00
14	9) Contingency	\$ 27,150.00
15	Total	\$125,000.00

16 Section 2. Allottee. The Governor is hereby designated allottee of the funds
 17 appropriated by this act. All funds appropriated by this act shall be allotted, managed,
 18 administered, and accounted for in accordance with applicable laws, including but not
 19 limited to, the Chuuk State Financial Management Act of 1982. The allottee shall be
 20 responsible for ensuring that these funds, or so much thereof as may be necessary, are
 21 used solely for the purpose specified in this act, and that no obligation are incurred in
 22 excess of the sum appropriated. Any funds not obligated on or before September 30,
 23 1998 shall automatically revert back into the General Fund.

1 Section 3. Report. The Governor shall submit a report to the Legislature on or
2 before September 30, 1998, which shall:

- 3 1) Provide for the full disclosure of the obligations incurred against the
4 sum appropriated by section 1, and indicate the status of the funds as
5 of September 30, 1998; and
- 6 2) indicate the planned use during the remainder of the fiscal year of the
7 funds not obligated as of September 30, 1998; PROVIDED, that a
8 supplemental report covering the actual use and obligation of the funds
9 shall be submitted to the Legislature, or an appropriate committee
10 thereof, within 10 days after the closing of the fiscal year.

11 Section 4. Effective Date. This act shall become effective upon approval by the
12 Governor, or upon its otherwise becoming law without such approval.




