

AN ACT

To appropriate the sum of \$173,997.00 from the General Fund of the State of Chuuk for the fiscal year ending September 30, 1998 for the purpose of funding travel and protocol for the heads of the branches of the State, food distribution, anesthesia training, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. The sum of \$173,997.00, or so much thereof as may be necessary, is
2 hereby appropriated from the General fund of the State for the fiscal year ending
3 September 30, 1998, for the purpose of funding the travel and protocol for the heads of
4 the branches of the State, food distribution and anesthesia training. The funds shall come
5 from FEMA reimbursement and investment earnings. The funds shall be apportioned
6 according to the following:


7	A. Heads of Branches Travel and Protocol	\$ 60,000.00
8	1. Governor's Office	\$ 20,000.00
9	2. President and Members, Senate	\$ 15,000.00
10	3. Speaker and Members, House	\$ 15,000.00
11	4. Chief Justice	\$ 9,997.00
12	B. Food Distribution	\$100,000.00
13	C. Anesthesia Training	\$ 14,000.00
14	Grand Total	\$173,997.00

15 Section 2. The sum appropriated by section 1 shall be administered by and is
16 allotted to the Governor, President, Speaker, and Chief Justice, who shall be responsible
17 to the Legislature for ensuring that these funds are used only for the purposes specified in
18 section 1, and in accordance with the State Financial Management Act, and that no
19 obligations are incurred in excess of the sum appropriated.


20 Section 3. The allottees shall submit a report to the Legislature on or before
21 September 15, 1998, which shall:

- 1 1) Provide for the full disclosure of the obligations incurred against the sum
- 2 appropriated by section 1, and indicate the status of the funds as of September
- 3 1, 1998; and
- 4 2) indicate the planned use, during the remainder of the fiscal year, of funds not
- 5 obligated as of September 1, 1998; PROVIDED, that a supplemental report
- 6 covering the actual use and obligation of the funds shall be submitted to the
- 7 Legislature, or an appropriate committee thereof, within 20 days after the
- 8 closing of the fiscal year.

9 Section 4. This act shall take effect upon approval by the Governor, or upon its
 10 becoming law without such approval.
