

AN ACT

To appropriate the sum of \$5,478,224 from CIP funds in the General Fund of the State for the fiscal year ending September 30, 1998, for the purpose of funding capital improvement projects for the municipal governments and the Chuuk MTN Loan payment, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. The sum of \$5,478,224, or so much thereof as may be necessary, is
2 hereby appropriated from CIP funds in the General Fund of the State for the fiscal year
3 ending September 30, 1998, for the purpose of funding capital improvement projects for
4 the municipal governments and the Chuuk MTN Loan payment. The funds shall be
5 apportioned as follows:

19 Section 2. The sum appropriated by section 1 shall be administered by and is
 20 allotted to the Governor, who shall be responsible to the Legislature for ensuring that
 21 these funds are used only for the purposes specified in section 1, and in accordance with
 22 the State Financial Management Act, and that no obligations are incurred in excess of the
 23 sum appropriated. Any part of this appropriation not obligated as of September 30, 1998,
 24 shall remain available until fully expended.


25 Section 3. The Governor shall submit a report to the Legislature on or before
 26 April 15, 1999, which shall:

- 27 1) Provide for the full disclosure of the obligations incurred against the
- 28 sum appropriated by section 1, and indicate the status of the funds as
- 29 of April 1, 1999; and
- 30 2) indicate the planned use, during the remainder of the fiscal year, of
- 31 funds not obligated as of April 1, 1999; PROVIDED, that a
- 32 supplemental report covering the actual use and obligation of the funds
- 33 shall be submitted to the Legislature, or an appropriate committee
- 34 thereof, within 20 days after the closing of the fiscal year.

1 Section 4. This act shall take effect upon approval by the Governor, or upon its
2 becoming law without such approval.
