

AN ACT

To appropriate the sum of \$2,500,000 from the General Fund of the State for the fiscal year ending September 30, 1998, for the purpose of payments under the State Deficit Reduction Program, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. The sum of \$2,500,000, or so much thereof as may be necessary, is
 2 hereby appropriated from the General Fund of the State for the fiscal year ending
 3 September 30, 1998, for the purpose of making required payments pursuant to the State
 4 Deficit Reduction Program. The fund shall come from current investment earnings and
 5 inflation adjustments of 1998. The fund shall be used as follows:

4 Section 2. The sum appropriated by Section 1 shall be administered by and is
 5 allotted to the Governor, who shall be responsible to the legislature for ensuring that these
 6 funds are disbursed by the Public Oversight Reform Committee only for the purposes
 7 specified in Section 1, and in accordance with the State financial Management Act, and
 8 that no obligations are incurred in excess of the sum appropriated. Any part of this
 9 appropriation not obligated as of September 30, 1998, shall remain available until fully
 10 expended

11 Section 3. The Governor shall submit a report to the legislature on or before April
 12 1, 1999, which shall:

- 13 1) Provide for the full disclosure of the obligations incurred against the
 14 sum appropriated by Section 1, and indicate the status of the funds as
 15 of April 1, 1999; and
- 16 2) indicate the planned use, during the remainder of the fiscal year, of
 17 funds not obligated as of September 30, 1998; PROVIDED, that a
 18 supplemental report covering the actual use and obligation of the funds
 19 shall be submitted to the legislature, or an appropriate committee
 20 thereof, within 20 days after the closing of the fiscal year.

21 Section 4. This act shall take effect upon approval by the Governor, or upon its
 22 becoming law without such approval.






