SECOND REGULAR SESSION, APRIL, 1998

ACT No: 4-25

AN ACT

To delegate to the municipal governments the power to tax in accordance with Section 7 of Article VIII of the Chuuk State Constitution, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1      Section 1. Delegation of Power to Tax. Pursuant to Section 7 of Article VIII of  
2      the Chuuk Constitution, the power to assess, levy and collect taxes be and the same is  
3      hereby delegated to the municipal governments of the State of Chuuk. Each municipal  
4      government at its own discretion may enact ordinances to that effect.

5      Section 2. Limitations. The power to tax granted herein does not authorize any  
6      municipality to assess, levy or collect any tax on the followings:

- 7            (a) tax on real property which is prohibited by Section 8 of Article VIII of  
8            the Chuuk State Constitution;
- 9            (b) tax which burdens or regulates inter-municipal commerce which is  
10          prohibited by Section 7 of Article XIII of the Chuuk State  
11          Constitution;
- 12          (c) surtax on subjects which have been preempted by taxes assessed,  
13          levied and collected by State law; or
- 14          (d) tax on subject that is preempted by the Constitution and laws of the  
15          Federated States of Micronesia.

16      Section 3. License. Each Municipality may enact ordinance requiring a person to  
17      obtain and pay for a business license before engaging or continuing in a business within  
18      the municipality in which the business is located. In such event, the following shall  
19      apply:

- 20            a) A business shall not be required to have more than one license for the  
21          same line of business at any one location within the municipality. For the  
22          purpose of this subsection a "line of business" means the products or  
23          services that are sold through a single business entity identified on the  
24          basis of whether it is a sole proprietorship, partnership, or corporation.

1                   b) The amount of license tax to charge a business may be established by  
2                   each municipal government through a licensing ordinance, but such tax  
3                   shall not exceed \$1,000 per year for any type of business.


4                   c) A roadside vendor license tax is \$5.00 per annum. For the purpose of  
5                   this Act, a roadside vendor is limited only to local fish and farm produce  
6                   temporary and not permanent in nature. Any roadside vendor other than  
7                   this type is prohibited under this Act.

8                   Section 4. Repeal. 29 TDC, sections 51-54 are hereby repealed.


9                   Section 5. Reserved Power. Notwithstanding the provisions of this act, the State  
10                  hereby expressly reserved the right to enact legislation to assess, levy and collect taxes on  
11                  any subject for which a tax has been assessed and levied by ordinance by any of the  
12                  municipality in the State of Chuuk. In the event that the State has enacted a legislation on  
13                  that same subject, the enactment of such legislation automatically repeals the ordinance  
14                  on the same subject.

15                  Section 6. Effective Date. This act shall become law upon its approval by the  
16                  Governor of Chuuk or upon its becoming law without such approval.
