ACT NO: 4-43

## AN ACT

To appropriate the sum of \$119,000.00 from the General Fund of the State for the fiscal year ending September 30, 1999, for the purpose of funding the Pacific Vocational Education Improvement Project (PVEIP) for Chuuk, Department of Education, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1       Section 1. The sum of \$119,000.00, or so much thereof as may be necessary, is  
2       hereby appropriated from the General Fund of the State for the fiscal year ending  
3       September 30, 1999, for the purpose of funding the Pacific Vocational Education  
4       Improvement Project (PVEIP) for the Department of Education, Chuuk State  
5       Government. The fund herein appropriated shall be apportioned according to the  
6       following:


7	A) Personnel	\$ 29,000.00
8	B) Fringe Benefits	\$ 2,500.00
9	C) Travel	\$ 10,000.00
10	D) Equipment	\$ 25,000.00
11	E) Materials & Supplies	\$ 20,000.00
12	F) Training	\$ 29,000.00
13	G) Others	\$ 3,500.00

14       Section 2. The funds herein appropriated, upon being allotted to the State, shall  
15       be deposited by the Director of Treasury into a Special Account of the General Fund, to  
16       allow continuity and to prevent interruption in the use of the fund due to cash flow  
17       problem.

18       Section 3. The sum appropriated by section 1 shall be administered by and is  
19       allotted to the Governor of Chuuk State, who shall be responsible to the Chuuk State  
20       Legislature for ensuring that these funds are used only for the purposes specified in  
21       section 1, and in accordance with the State Financial Management Act, and that no  
22       obligations are incurred in excess of the sum appropriated. Any part of this appropriation  
23       not obligated as of September 30, 1999, shall remain available until fully expended.


- 1           Section 4. The Governor shall submit a report to the Legislature on or before  
2           April 15, 1999, which shall:
- 3           1) Provide for the full disclosure of the obligations incurred against the  
4           sum appropriated by section 1, and indicate the status of the funds as  
5           of April 15, 1999; and  
6           2) indicate the planned use, during the remainder of the fiscal year, of  
7           funds not obligated as of September 30, 1999; PROVIDED, that a  
8           supplemental report covering the actual use and obligation of the funds  
9           shall be submitted to the Legislature, or an appropriate committee  
10           thereof, within 20 days after the closing of the fiscal year.
- 11           Section 5. This act shall take effect upon approval by the Governor, or upon its  
12           becoming law without such approval.






