

FIFTH LEGISLATURE OF THE STATE OF CHUUK CHUUK STATE LAW NO. 5-00-26
SECOND REGULAR SESSION, APRIL, 2000 ACT NO: 5-27

AN ACT

To authorize the Governor of Chuuk to negotiate a loan from any lending institution to fund certain important public projects in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. Authorization. The Governor is hereby authorized to negotiate a loan
2 from any lending institution insured by the Federal Deposits Insurance Corporation and,
3 in connection therewith, to enter into any loan agreement with such lending institution for
4 a loan not to exceed \$10,000,000.00, exclusive of interests and bank charges, on behalf of
5 the Government of the State of Chuuk.

6 Section 2. Agreements and Collateral. The governor is hereby further authorized
7 to negotiate any and all agreements required by the lending institution and to pledge as
8 security of future income for the Government of Chuuk from local revenues, from the
9 future compact funds, and from any other sources not enumerated herein in full
10 compliance with State and National law with all such agreements and pledges of security
11 subject to Senate approval pursuant to the Restrictive Measures Act.


12 Section 3. Use of Borrowed Fund. The proceeds of the loan to be obtained
13 pursuant to this act shall be used to purchase the land requirements for the Government of
14 the State of Chuuk, and if there is any surplus thereof, the same shall be used to liquidate
15 the past existing debts of the Government of Chuuk.

16 Section 4. Appropriation. The borrowed fund shall be deposited in the General
17 Fund of Chuuk State subject to appropriation by the Legislature for expenditure solely in
18 compliance with the Financial Management Act.

19 Section 5. Authorization for Future Appropriation. There is hereby authorized to
20 be appropriated annually the such sum as are necessary and proper for the purpose of
21 repaying the loan to be obtained pursuant to this act. The annual appropriation for the
22 repayment of the loan shall be considered as one of the top priorities on the Legislature's
23 appropriation list.

- 1 Section 6. Effective Date. This act shall become effective upon approval by the
2 Governor or upon its otherwise becoming law without such approval.


