

FIFTH LEGISLATURE OF THE STATE OF CHUUK CHUUK STATE LAW NO. 5-00-27
SECOND REGULAR SESSION, APRIL, 2000 ACT NO: 5-26

AN ACT

To further amend section 4 of Truk State Law No. 5-119, as amended by CSL Nos. 191-04, 2-93-06, 2-94-15 and 3-96-01, by increasing certain taxes of some items hereunder, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. Amendment. Section 4 of Truk State Law No. 5-119 as amended by
2 CSL No. 191-04, 2-93-06, 2-94-15 and 3-96-01, is hereby amended to read as follows:

3 "Section 4. Sales Tax, Imposition. There is hereby levied a tax on the first sale in
4 the State of Chuuk of all tangible items, except gasoline and diesel fuel, and unprocessed
5 and unpackaged items, as follows:

- 6 1) tobacco at a rate of thirty percent of the sales price;
- 7 2) cigarettes at a rate of fifty cents per pack of twenty cigarettes;
- 8 3) luxury items at a rate of ten percent of the sales price;
- 9 4) diesel, kerosene and Jet A-One Kerosene at a rate of five cents per
10 gallon,
- 11 5) all other items at a rate of five percent of the sales price."


12 Section 2. Allotment. All money collected pursuant to sections 1,2,3 and 4 of
13 this act shall be allotted to the Governor of the State of Chuuk and such funds earmarked
14 exclusively for programs that are direly needed for the State of Chuuk. The Governor
15 shall ensure that expenditure of these funds are expended accordingly and he shall submit
16 a report to the Legislature regarding such expenditure no later than September 30, 2000.

1 Section 3. Effective date. This act shall take effect upon approval by the
2 Governor, or upon its becoming law without such approval.






