AN ACT


To further amend section 2 of Chuuk State Law No. 190-13, as amended by Chuuk State Law No. 5-99-18, by providing that only departure fees collected after September 30, 2000, be used for the purpose specified in section 2 as amended, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:


1 Section 1. Amendment. Section 2 of Chuuk State Law No. 190-13, as amended
2 by Chuuk State Law No. 5-99-18, is hereby further amended to read as follows:

3 “Section 2. Imposition of Fees. There is hereby levied or imposed, in
4 addition to all other fees of every kind, a departure fee of fifteen dollars (\$15.00)
5 per passenger upon his or her departure from Chuuk State to any destination
6 outside of Chuuk State. All fees collected pursuant to this act after September 30,
7 2000 shall be deposited into the General Fund of the State and be earmarked
8 exclusively for maintenance, renovations and expansion of the airport terminal
9 and other most relevant expenditure of the Chuuk International Airport.”

10 Section 2. Effective Date. This act shall become effective upon approval by the
11 Governor, or upon its otherwise becoming law without such approval.
