

AN ACT

To appropriate the sum of \$512,000.00 from the General Fund of the State of Chuuk for the fiscal year ending September 30, 2000 for the purpose of supplementing the operation budget of the Chuuk State Government, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:


1 Section 1. Appropriation. There is hereby appropriate the sum of \$512,000.00  
2 from the General Fund of the State of Chuuk for the fiscal year ending September 30,  
3 2000, not otherwise appropriated, for the purpose of supplementing the current operation  
4 budget of the Chuuk State Government.

5 Section 2. Sources of Funding. The funds appropriated under section 1 of this act  
6 come from State local revenues, from the fiscal year 1999 surplus, and from local  
7 revenues collection, in the amount of \$232,000.00 and \$280,000.00 respectively.

8 Section 3. Allottee of Funds. The Governor is hereby designated allottee of the  
9 funds appropriated pursuant to section 1 of this act, and as such he shall ensure all of the  
10 funds are used for the purposes for which they are appropriated and that said funds shall  
11 be accounted for in accordance with acceptable accounting principles. The allottee shall  
12 submit a report of the use of the funds simultaneously with his report on the use of the  
13 funds for the operation budget for the fiscal year 2000.


14 Section 4. Effective Date. This act shall become effective upon approval by the  
15 Governor, or upon its otherwise becoming law without such approval.
