ACT NO: 5-42

AN ACT

To specifically authorize the Government of the State of Chuuk, pursuant to the provisions of Chuuk State Law No. 5-00-26 and in furtherance thereof, to obtain a Loan from the Bank of Hawaii and to specify the terms and conditions for such Loan, and for other purpose.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

Section 1. Authorization for Loan. Pursuant to Chuuk State Law No. 5-00-26, 1 2 the Governor of Chuuk is authorized to borrow, on behalf of the Government of the State 3 of Chuuk the principal amount U.S. FOUR MILLION DOLLARS (U.S. \$4,000,000.00)("Loan") from the Bank of Hawaii for the public purposes set forth in 4 Chuuk Law State Law No. 5-00-26. 5 6 Section 2. <u>Terms and Conditions</u>. Except as may be otherwise provided in this Act, the terms and conditions of the Loan shall be as determined by the Governor by 7 8 execution of a Loan agreement, promissory note, security agreement and other Loan agreements as the Bank of Hawaii may require. Provided the Loan shall be secured by a 9 pledge and first lien upon a time certificate of deposit or other deposit dully established 10 by the State of Chuuk with the Bank of Hawaii, which deposit shall be in the principal 11 amount of U.S. FOUR MILLION DOLLARS (U.S. \$4,000,000.00) as authorized and 12 13 appropriated for public purposes pursuant to the provisions of Chuuk State Law No. 5-00-38. The deposit shall be subject no lien or claim or encumbrance of any kind other 14 15 than the security interest of the Bank of Hawaii.

Section 3. <u>Valid and Binding Obligations</u>. The Loan authorized by Chuuk State Law No. 5-00-26 as amended and confirmed by this Act shall constitute the valid and binding general obligation of the Government of the State of Chuuk. The Government of the State of Chuuk pledges its full faith and credit for the punctual payment of both principal and interest on the Loan. There shall be collected annually in the same manner and at the same time as Government revenue for other purposes is collected, such sum as is required to pay the principal of and interest on the Loan and all officers charged by law with any duty in the collection of the revenues of the Government shall do every lawful
thing necessary to collect such sum. The Government shall faithfully observe and
perform all the covenants, conditions and requirements of the Loan and with all Loan
agreements and Loan documents.

5 Section 4. <u>Waiver of Immunity</u>. Notwithstanding any substantive or procedural provision of any other applicable law, the Government of the State of Chuuk hereby 6 7 waives immunity from any suit or action in contract on the Loan, and waives all 8 governmental immunity and sovereign immunity with respect to the Loan. Provided that 9 no elected official, officer, agent or employee of the Government shall be individually or personally liable for payment of the principal or interest on the Loan, but nothing herein 10 11 contained shall relieve any such elected official, officer, agent or employee from the 12 performance of any official duty provided by law. The Government of the State of 13 Chuuk additional authorizes the Governor to waive any defense available under the U.S. Foreign Sovereign Immunities Act, 28 U.S.C. Section 1602-1611 (1987), the Act of State 14 doctrine and any similar law. The Government of the State of Chuuk additionally 15 authorizes the Governor to consent to jurisdiction of the courts of the State of Hawaii or 16 of the United States Federal court sitting in the State of Hawaii over any action, suit or 17 18 proceeding arising out of or relating to the Loan.

Section 5. <u>Conflict</u>. This Act and its provisions shall prevail and control in the
event and to the extent of any inconsistency or conflict that may exist with any other
provision of law, including without limitation Chuuk State Laws No. 5-00-26, 5-00-38
and 5-00-39.

Section 6. <u>Effective Date</u>. This Act shall become effective upon approval by the
 Governor or upon as otherwise becoming law without such approval
