## AN ACT

To appropriate the sum of \$8,500.00 from the General Fund of the State for the fiscal year ending September 30, 1999, for the purpose of funding the Vision and Dreams Program of the Department of Education, Chuuk State Government, and for other purposes.

## BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

Section 1. The sum of \$8,500.00, or so much thereof as may be necessary, is

- 2 hereby appropriated from the General Fund of the State for the fiscal year ending
- 3 September 30, 1999, for the purpose of funding the Vision and Dreams Program of the
- 4 Department of Education in Chuuk State to be allocated as follows:

5	I. Kuttu Elementary School	\$3,500.00
6	II. Parem Elementary School	2,000.00
7	III. Kuchu Elementary School	3,000.00

- Section 2. The sum appropriated by section 1 shall administered by and is allotted to the Governor, who shall be responsible to the Legislature for ensuring that these funds
- are used only for the purposes specified in section 1, and in accordance with the State
- Financial Management Act, and that no obligations are incurred in excess of the sum
- appropriated. Any part of the appropriation not obligated as of September 30, 1999, shall
- remain available until fully expended.

- Section 3. The Governor shall submit a report to the Legislature on or before
  September 30, 1999, which shall:
- 1) Provide for the full disclosure of the obligations incurred against the sum
  appropriated by section 1, and indicate the status of the funds as of
  September 30, 1999; and
- 19 2) indicate the planned use of the funds not obligated as of September 30, 1999; 20 PROVIDED, that a supplemental report covering the actual use and obligation 21 of the funds shall be submitted to the
