1	Section 1. The sum of \$500,000.00, or so much thereof as may be necessary, is
2	hereby appropriated from the General Fund of the State for the fiscal year ending

9	the purposes specified above, and in accordance with the State Financial Management Act,
10	and that no obligation is incurred in excess of the amount herein appropriated. Any part
11	of this appropriation not obligated as of September 30, 1999 shall remain available until
12	fully expended.
13	Section 3. Every allottee of funds in this act shall submit a report to the Legislature
14	on or before November 30, 1999, which shall include the full disclosure of the obligations
15	charged against the sum appropriated by section 1, and the status of these funds as of
16	November 15, 1999.
17	Section 4. Effective Date. This act shall take effect upon approval by the
