AN ACT

To appropriate the sum of \$120,000.00 from the General Fund of the State for the fiscal year ending September 30, 2000, for the purpose of funding the Pacific Vocational Education Improvement Program (PVEIP) of the Department of Education, Chuuk State Government, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

Section 1. The sum of \$120,000, or so much thereof as may be necessary, is

2 hereby appropriated from the General Fund of the State for the fiscal year ending

3 September 30, 2000, for the purpose of funding the PREL Pacific Vocational Education

4 Improvement Program (PVEIP) for Chuuk State, Department of Education. The fund

Section 2. The funds appropriated by Section 1 of this Act, upon allotted to the
State, shall be deposited into a special account of the State General Fund, in order to
allow continuity and to prevent interruption in the use of the said fund due to possible cash
flow problem.

The sum appropriated by Section 1 shall be administered by and be 19 allotted to the Governor, who shall be responsible for ensuring that these funds are used 20 only for the purposes as specifically provided in Section 1, and that no obligations are 21 incurred in excess of the sum appropriated.
