

AN ACT

To appropriate the sum of \$120,000.00 from the General Fund of the State for the fiscal year ending September 30, 2000, for the purpose of funding the Pacific Vocational Education Improvement Program (PVEIP) of the Department of Education, Chuuk State Government, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. The sum of \$120,000, or so much thereof as may be necessary, is
2 hereby appropriated from the General Fund of the State for the fiscal year ending
3 September 30, 2000, for the purpose of funding the PREL Pacific Vocational Education
4 Improvement Program (PVEIP) for Chuuk State, Department of Education. The fund
5 herein appropriated shall be allocated as follows:

6	A. Personnel	\$29,000.00
7	B. Fringe Benefits	2,500.00
8	C. Travel	10,000.00
9	D. Equipment	25,000.00
10	E. Materials & Supplies	15,000.00
11	F. Training	35,000.00
12	G. Other	<u>3,500.00</u>
13	Total	\$120,000.00


14 Section 2. The funds appropriated by Section 1 of this Act, upon allotted to the
15 State, shall be deposited into a special account of the State General Fund, in order to
16 allow continuity and to prevent interruption in the use of the said fund due to possible cash
17 flow problem.

18 Section 3. The sum appropriated by Section 1 shall be administered by and be
19 allotted to the Governor, who shall be responsible for ensuring that these funds are used
20 only for the purposes as specifically provided in Section 1, and that no obligations are
21 incurred in excess of the sum appropriated.


22 Section 4. The Governor shall submit a fund status report to the Legislature on or
23 before April 15, 2000, which shall:

- 1 A) Provide for the full disclosure of the obligations incurred against the
2 sum appropriated by Section 1; and
3 B) indicate the planned use of the remaining funds for the rest of the fiscal
4 year.


5 Section 5. This Act shall take effect upon approval by the Governor, or upon its
6 becoming law without such approval.


