

AN ACT

To establish and define the salary and entitlement of the Governor of the State of Chuuk as required by the Chuuk State Constitution, Article XV, Section 10, and for other purposes.

1 BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

2 Section 1. Short Title. This Act may be cited as the Chuuk State Executive Salary
3 and Entitlement Act

4 Section 2. Purpose. The purpose of this Act is to bring further clarity to the
5 salary and expense requirements provided to the Governor by statute. Chuuk State
6 Constitution, Article V, Section 8, under subsection (a) and (b) states, “ (a) except as
7 limited by this Constitution, members of the Legislature shall receive annual salaries as
8 presented by statute. No member may receive as salary and expense allowance a total
9 amount greater than $\frac{3}{4}$ of the equivalent to which the Governor is entitled by law; (b) The
10 expense allowance for each member of the Legislature may not exceed $\frac{1}{5}$ of the
11 members’ annual salary.”

12 Section 3. Definitions. As used in this Act, unless the context clearly requires
13 otherwise:

14 (1) “Allowance” a deduction, an average payment, a portion assigned or allowed;
15 the act of allowing.

16 (2) “Salary” a reward or recompense for services performed. In a more limited
17 sense, a fixed periodical compensation paid for services rendered. A stated
18 compensation paid periodically as by the year, month, or other fixed period, in
19 contrast to wages which are normally based on an hourly rate.


20 Section 4. Entitlement. For the purpose of this act, the Chuuk State Governor’s
21 salary and expenses shall include the following

22 (a) A salary of \$36,000.00 per year as defined by statute;

23 (b) Housing; \$7,000


24 (c) vehicle; \$20,000 and


1 (d) representation allowance; \$37,000
2 Section 5. Effective Date. This act shall become effective upon approval by the
3 Governor, or upon its otherwise becoming law without such approval.




