AN ACT

To amend Section 2 of Chuuk State Law No. 190-13, as amended by Chuuk State Law No. 5-99-18 to provide additional use of the monies generated by this Act, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:


1        Section 1. Amendment. Section 2 of Chuuk State Law No. 190-13, as amended  
2        by Chuuk State Law No. 5-99-18, is hereby further amended, to read as follows:

3                "Section 2. Imposition of Fee. There is hereby liveied or imposed, in  
4        addition to all other fees of every kind, a departure fee of fifteen dollars (\$15.00)  
5        per passenger upon his or her departure from Chuuk State to any destination  
6        outside of Chuuk State. Fifty percent (50%) of all fees collected pursuant to this  
7        act shall be earmarked exclusively for maintenance, renovations and expansion of  
8        the Airport terminal and other most relevant expenditure of the Chuuk  
9        International Airport, and the remaining fifty percent (50%) shall be used for the  
10      operation cost of the Chuuk State Government."

11        Section 2. Effective Date. This Act, upon approval by the Governor, or upon its  
12      becoming law without such approval, shall take effect on October 1, 2001.


