

AN ACT

To repeal Title 3 of the Truk District Code in its entirety, and to give the Chuuk State Government direct control over the sale and consumption of alcohol, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE

- 1 Section 1. Definitions. As used in this Act, unless specifically provided:
- 2 (c) "Alcohol" means ethyl alcohol produced by the distillation of any
- 3 fermented liquid, whether rectified or diluted with water or not,
- 4 whatever may be the origin thereof, and includes synthetic ethyl
- 5 alcohol, but it does not mean ethyl alcohol, diluted or not, that has
- 6 been denatured or otherwise rendered unfit for beverage purposes.
- 7 (d) "Alcoholic liquor" or "alcoholic liquors" include the 5 varieties of
- 8 liquor defined in this section (alcohol, spirits, wine, beer and alcoholic
- 9 cider) as well as every liquid or solid, patented or not, containing
- 10 alcohol, spirits, wine, beer or alcoholic cider and capable of being
- 11 consumed by a human being, and any liquid or solid containing more
- 12 than 1 of 5 varieties defined in this section is considered as belonging
- 13 to that variety which usually has the higher percentage of alcohol. A
- 14 concentrated alcoholic beverage shall be an "alcohol liquor" for
- 15 purposes of this title, in addition to their usual meaning.
- 16 (e) "Establishment" means any place located physically in this State where
- 17 alcoholic liquor of 1 or more varieties is stored, sold or used by
- 18 authority of any law of this State, including a hotel, restaurant, tavern
- 19 or club as defined in this section, or where alcoholic liquor of 1 or
- 20 more varieties is manufactured by virtue of any law of this State.
- 21 (f) "Import" means the transporting or ordering or arranging for the
- 22 transportation or shipment of alcoholic liquor into the State whether by
- 23 a resident of the State or otherwise.

1 (g) "License" means any license or permits to manufacture, to sell, to
2 purchase, to transport, to import or to possess alcoholic liquor
3 authorized or issued by the State under the provisions of this Act.

4 (h) Sale means every act of selling as defined in this section.

5 (i) Sell means solicit or receive an order for, keep or expose for sale;
6 deliver for value or in any other way than purely gratuitously; keep
7 with intent to sell; keep or transport in contravention of this title;
8 trafficking for any valuable consideration promise or obtained, directly
9 or indirectly, or under any pretext or by any means whatsoever,
10 procure or allow to be procured for any other person, to carry alcoholic
11 liquors on one's person or to transport with one and with intent to sell
12 the same, but not in any establishment where the sale thereof is
13 allowed

14 (j) Spirits means any beverage containing more than one half of 1 percent
15 of ethyl alcohol by volume mixed with water and other substances in a
16 solution, and includes, among other things, brandy, rum, whiskey and
17 gin.

18 Section 2. Repeal. Title 3 of the Truk District Code is hereby repealed in its
19 entirety.

20 Section 3. Grant of Authority. For the purposes of this Act, the Chuuk State
21 Government hereby has the sole authority to administer and control the sale of alcohol
22 within the State.

23 Section 4. Extent of Effectiveness. Nothing in this title shall be interpreted as
24 authorizing the manufacture, distribution, sale, transportation or importation of alcoholic
25 liquors, alcoholic, spirits, wines or beer, as defined in Section 1 of this Act, where such
26 manufacture, distribution, sale, transportation or importation is prohibited by the
27 Constitution of the Federated States of Micronesia, or under the statutes thereof.

28 Section 5. Alcoholic Beverage Control Board – Composition. There shall be an
29 Alcoholic Beverage Control Board, which shall consist of five members appointed by the
30 Governor for terms of two years each. The Chuuk Director of Public Safety and Chuuk

1 State Director of Health Services shall serve as ex-officio members of the Board. The
2 Governor shall designate one of the members as Chairman of the Board.

3 Section 6. Ineligibility. A person is not eligible for membership on the Board
4 who:

5 (a) is or becomes interested, directly or indirectly, in any businesses
6 involving the importation, manufacture, or sale of alcoholic beverages;
7 PROVIDED, that ownership of stock alone shall not constitute an
8 "interest" under this Section;

9 (b) Has not reached the age of thirty years; and,

10 (c) Has been convicted of a felony for which he has not had reversed on
11 appeal.

12 Section 7. Disqualification and removal. The Governor shall remove any member
13 of Board whenever grounds for disqualification appear.

14 Section 8. Compensation. Every member of the Board who is not in the service
15 of the Governmental for which he receives compensation shall be a determined by the
16 Governor and the Chuuk State Legislature.

17 Section 9. Power. The Board shall have the power to license the importation,
18 manufacture, and sale of alcoholic beverage and to suspend, revoke, and reinstate such
19 licenses.

20 Section 10. Regulations. The board shall make regulations consistent with the
21 provisions of this Chapter and amend or repeal such regulations as it deems necessary to
22 carry out the intention of this Chapter and to exercise the powers and perform the duties
23 conferred upon it.

24 Section 11. Power to require records to report. The board shall have the power to
25 prescribe the Character and manner of keeping books and records by licensee and to
26 require such reports from licensee and to require such reports from licenses, common and
27 private carriers and other persons necessary to enable the Board to exercise its powers
28 and duties.

29 Section 12. Power to Prescribe forms. The Board shall prescribe the form of all
30 applications for licenses or renewal of licenses and other papers it shall require including

1 verification, and the information to be contained shall prescribe the place for posting
2 licenses by licenses.

3 Section 13. Fee. The Board shall cause all fees received by it to be paid to the
4 Chuuk State Treasury.

5 Section 14. Records.

6 (a) The Board shall cause special records to be prepared of all its
7 meetings, proceedings, and business, including the number, class, and
8 kinds of licenses issued, denied, suspended and revoked, and monies
9 received and dispersed, which records shall be open to public
10 examination.

11 (b) The Board shall render a report to the Governor and the Legislature
12 thirty (30) days prior to the close of each fiscal year, setting forth the
13 details of all of its activities for the preceding year, based upon such
14 records.

15 Section 15. Meetings. Meetings shall be held periodically, as conditions require,
16 and shall be called by the Chairman.

17 Section 16. Procedure for application. All members of the Board shall have the
18 opportunity to consider each license application and shall either approve or disapprove
19 the same. The Chairman shall review the application first, sending it then to each of the
20 members in turn. A simple majority of the membership shall constitute a quorum and a
21 decision by the majority present shall prevail.

22 Section 17. License required. Except as otherwise provided in this Chapter a
23 person shall not import, manufacture, or sell alcoholic beverages without a
24 license.

25 Section 18. Licenses: Lack of Disposal of stock. A person in possession of a
26 stock of lawfully acquired alcoholic beverages following the revocation or voluntary
27 relinquishment of a license to sell the same, may sell such stock under the supervision of
28 the Board and in such manner as the Board shall by regulation prescribe to a license
29 authorized to sell such alcoholic beverages.

30 Section 19. Exception: Sacramental Wine. A religious organization may import
31 wine for use in its rites without the necessity of a license under this Chapter.

1 Section 20. New Arrivals. A person entering Chuuk State for the first time or
 2 returning after an absence of fifteen or more days bring with him for private use, and not
 3 for resale, alcoholic beverages not exceeding one gallon in quantity without a license.

4 Section 21. License-Classes and fees. There shall be the following classes of
 5 licenses and fees thereafter.

- 6 (a) Class 1: Wholesale agent;
 - 7 (i) Beer and wine..... \$300.00
 - 8 (ii) General..... 400.00
- 9 (b) Class 2. Retail dealer's on sale license;
 - 10 (i) Beer and wine \$100.00
 - 11 (ii) General 200.00
- 12 (c) Class 3. Retail dealer's off-sale license,
 - 13 (i) Beer and wine \$100.00
 - 14 (ii) General 200.00
- 15 (d) Club license \$400.00

16 Section 22. Fees: Reductions. If an applicant applies for a license after the
 17 beginning of a fiscal year but during the first quarter of the year, he shall pay the full gee
 18 therefore. If he applies after the end of the first quarter and during the second quarter, he
 19 shall pay three-fourths of the fee. If he applies after the end of the second quarter, he
 20 shall pay one-half of the fees regardless of when he applies.

21 Section 23. Expiration date. The licenses specified in Section 21 of this Chapter
 22 shall be issued for an indefinite period; PROVIDED HOWEVER, that each licenses
 23 shall pay an annual fee as specified in Section 21 of this Chapter for the issuance of
 24 licenses, payable on and before the thirtieth day of June of each year, beginning with the
 25 thirtieth day of June following the issuance of the license. If the license fee is not paid on
 26 or before the thirtieth day of June of each year, the license is automatically suspended,
 27 but may be reinstated by the board within three days after the thirtieth day of June upon
 28 payment of the license fee. Unless the license is so reinstated, it is automatically revoked
 29 thirty-one days after the thirtieth day of June, and the board shall not issue a license
 30 except upon a new, original application.

1 Section 24. Privilege-Limitations. A licensee is limited to the privileges conferee
2 by the license, and is not authorized to exercise any other privileges.

3 Section 25. Limitations. A licensee is limited to the premises for which the
4 license is issued and is not authorized to exercise the privileges conferred by the license
5 at any additional or other premises.

6 Section 26. Wholesaler. A person holding a wholesale dealer's license is
7 authorized to import and purchase from a manufacturer, agent or wholesaler, the
8 alcoholic beverages specified by the board, and to sell such alcoholic beverages to
9 licensed retail establishments or to religious organizations.

10 Section 27. Retail on-sale. A person holding a retail dealer's license is
11 authorized to sell alcoholic beverages, as specified in the license, to consumers for
12 consumption on the premises.

13 Section 28. Retail off-sale. A person holding a retail dealer's off-sale license is
14 authorized to sell alcoholic beverages, as specified in the license, to consumers for
15 consumption off the premises.

16 Section 29. Club. A club license shall be a combined general retail on-sale and
17 retail off-sale license and shall authorize the club and guests thereof enjoying the
18 privilege of membership.

19 Section 30. Real party in interest. The Board shall not issue a license of any class
20 to any applicant who is not the real party in interest.

21 Section 31. License-Minor. The Board shall not issue any license to any person
22 who is under twenty-one years of age.

23 Section 32. Prior revocation. Except in the case of a license revoked for non-
24 payment of renewal fee, the board shall not issue a license of any class, which was
25 revoked within a one-year period prior to the date of the application.

26 Section 33. Unfit person. The Board shall not issue a license of any class to any
27 person the board deems unfit to hold a license.

28 Section 34. Near Church Hospital School. The Board shall not issue an on-sale
29 license for premises located within a distance of one hundred feet from the premises of
30 any church, hospital or public or private school.

1 Section 35. License-On Sale-Number. The Board shall not issue a greater
2 number of on-sale licenses for premises located within a distance of one hundred feet
3 from the premises of any church, hospital, or public or private school.

4 Section 36. Board-Disapproved of application. The Board may disapprove an
5 application for a license, upon finding through adequate investigation that such refusal is
6 in the public interest.

7 Section 37. License denial: Review. Where an application for license has been
8 denied in accordance with Section 36 of this Chapter, the applicant may appeal the
9 decision of the board to the, Governor who shall have the authority to direct the Board to
10 issue the license.

11 Section 38. Conduct of business. A licensee, whether wholesaler or retailer, shall
12 not encourage the consumption of alcoholic beverages, but shall confine his business to
13 the supply of the demand for alcoholic beverages in a dignified manner in accordance
14 with the intent of the provisions of this Chapter.

15 Section 39. Condition of premises. The Board shall have the power to prescribe
16 by regulation the arrangement, construction, equipping, lighting and sanitary facilities of
17 any premises as will provide a safe and sanitary premise with sufficient lighting and
18 orderly atmosphere.

19 Section 40. Unauthorized alcoholic beverages: Possession forbidden. A license
20 shall not keep upon the premises any alcoholic beverages other than those are authorized
21 to deal in by virtue of his license.

22 Section 41. Hours of sale: On-sale premises. An on-sale licensee shall not sell or
23 serve any alcoholic beverages after ten p.m. Sundays through Thursdays, nor after
24 twelve midnight on Fridays and Saturdays. A licensee may begin selling and serving
25 alcoholic beverages at twelve noon on Sundays through. Thursday and at none a.m.
26 Fridays and Saturdays. (Note, I feel as though alcohol sales should not be allowed on
27 Sundays, except on Club and on sale retail sites).


28 Section 42. Hours of sale: Off-sale. An off-sale license shall not sell alcoholic
29 beverages before seven-thirty a.m. and after ten-thirty p.m.


30 Section 43. Holidays: An on or off-sale licensee shall not sell or serve alcoholic
31 beverages in the state during the following Holidays:

1 place. Violators of this section shall be fined not more than fifty dollars, or imprisoned
2 for a period of not more than fifty days, or both such fine and imprisonment.

3 Section 58. Minor—Consumption or Possession. It shall be unlawful for any
4 person under the age of twenty-one years to possess or consume any alcoholic beverage,
5 either of local manufacture or imported into the Chuuk State. Violators of this section
6 shall be fined not more than fifty dollars, or imprisoned for not more than three months,
7 or both.

8 Section 59. Effective Date. This act shall take effect upon its approval by the
9 Governor, or upon its becoming law without such approval.


