

AN ACT

To appropriate the sum of \$120,000.00 from the General Fund of the State for the fiscal year ending September 30, 2002, for the purpose of funding the PREL, Pacific Vocation Education Improvement Program (PVEIP) of the Department of Education, Chuuk State Government, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. The sum of \$120,000.00, or so much thereof as may be necessary, is
2 hereby appropriated from the General Fund of the State for the fiscal year ending
3 September 30, 2002, for the purpose of funding the Pacific Vocational Education
4 Improvement Program (PVEIP) of the Department of Education, Chuuk State
5 Government. The Fund shall be appropriated according to the following:



14 Section 2. The sum appropriated herein, upon being allotted to the State, shall be
15 deposited by the Director of Finance into a PREL Special Account of the General Fund
16 of the State, to allow continuity and to prevent interruption in the used of the fund due to
17 cash flow problem.


18 Section 3. The sum appropriated in Section 1 shall be administered by and is
19 allotted to the Governor, who shall be responsible to ensure that these funds are used only
20 for the purpose specified in Section 1, and in accordance with the State Financial
21 Management Act, and that no obligations are incurred in excess of the sum appropriated.
22 These funds shall be used until fully expended.

1 Section 4. The Governor shall submit a written report to the Legislature on or
2 before April 15, 2002, which shall provide the full disclosure of the obligations incurred
3 against the sum appropriated by Section 1 and indicate the status of the funds as of April
4 15, 2002.


5 Section 4. This Act shall take effect upon approval by the Governor, or upon its
