

## AN ACT

To appropriate the sum of \$2,140,192 from the Capital Account, \$2,663,424 from the Bump-Up Capital Account and \$1,556,881 from the Bump-Up Current Account of the General Fund of the State for the fiscal year ending September 30, 2003, for the purpose of funding the State's contribution to the Trust Fund for the Compact II, the State's outstanding allotment payments to Social Security for state government employees, Public Safety patrol vehicles, SARS Prevention, Government Employees Group Life Insurance, Special Election, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1           Section 1. Appropriation. The sum of \$2,140,192 from the Capital Account,  
2           \$2,663,424 from the Bump-Up Capital Account and \$1,556,881 from the Bump-Up  
3           Current Account of the General Fund of the State of Chuuk, for the fiscal year ending  
4           September 30, 2003, for the purpose of funding the State's contribution to the Trust Fund  
5           for the Compact II the State's outstanding allotment payments to Social Security for state  
6           government employees, Public Safety patrol vehicles, SARS Prevention, Government  
7           Employees Group Life Insurance, and Special Election. The funds shall be apportioned  
8           as follows:

9           1) \$6,055,488 - Trust Fund

10                 a) \$2,140,192           Capital Account

11                 b) \$2,663,424           Bump-Up Capital Account

12                 c) \$1,251,872           Bump-Up Current Account

13           2) \$ 225,009 - Social Security Payment (Bump-Up Current Account)

14           3) \$ 30,000 - Public Safety Patrol Vehicle (Bump-Up Current Account)

15           4) \$ 25,000 - SARS Prevention (Bump-Up Current Account)

16           5) \$ 15,000 - Government Employees Group Life Insurance  
17   (Bump-Up Current Account)

18           6) \$ 10,000 - Special Election (Bump-Up Current Account)


19           Section 2. Administration. The funds appropriated pursuant to section 1 of this  
20           act shall be administered by and is allotted to the Governor, who shall be responsible to  
21           the Legislature for ensuring that funds herein appropriated are used only for the purposes

1 specified in section 1, and in accordance with the State Financial Management Act, and  
2 that no obligation are incurred in excess of the sum appropriated.

3 Section 3. Report. The Governor shall submit a report to the Legislature and this  
4 report shall include full disclosure of all the funds obligated and their status as of  
5 September 1, 2003.


6 Section 4. Effective Date. This act shall become effective upon approval of the
