

SEVENTH LEGISLATURE OF THE STATE OF CHUUK

ACT NO: 7-11

AN ACT

To appropriate the sum of \$564,845.00 from the General Fund of the State for the fiscal year ending June 30, 2004 for the purpose of funding the School Improvement Project in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CHUUK STATE LEGISLATURE:

1 Section 1. Appropriation. The sum of \$564,845.00, or so much thereof as may be  
2 needed, is hereby appropriated from the General Fund of the State of Chuuk for the fiscal  
3 year ending June 30, 2004, for the purpose of funding the School Improvement Project  
4 (SIP), a federally funded program of CSSS. The funds are to be used according to the  
5 following breakdown:

14 Section 2. Administration. The sum appropriated by section 1 shall be allotted to  
15 and administered by the Governor of the State, and shall be used in conformity with the  
16 provisions of the Chuuk State Financial Management Act. However, in the event a  
17 reprogramming may be needed, such reprogramming shall require prior approval of the  
18 awarding agency. Furthermore, any part of the appropriation not obligated as of June 30,  
19 2004, shall remain until fully expended.

20 Section 3. Reporting. The Governor shall submit a report to the Legislature on or  
21 before January 15, 2004, which shall:

- 22 1) Provide for the full disclosure of the obligations incurred against the  
23 sum appropriated by section 1, and indicate the status of the funds as  
24 of January 1, 2004; and

1                    2) Indicate the planned use, during the remainder of the fiscal year, of  
 2                    funds not obligated as of January 1, 2004; PROVIDED, that a  
 3                    supplemental report covering the actual use and obligation of the funds  
 4                    shall be submitted to the Legislature, or an appropriate committee  
 5                    thereof, within 20 days after the closing of the fiscal year.

6                    Section 4. Effective Date. This act shall take effect upon approval by the  
 7                    Governor, or upon its becoming law without such approval.


