ACT NO: 8-20

## A BILL FOR AN ACT

To appropriate the sum \$500,000 from the General Fund of the State, for the purpose of supplementing the funding for the construction of the Legislative Complex, and for other purposes.

Be it enacted by the Chuuk State Legislature:

Section 1. Appropriation. The sum of \$500,000, or so much thereof as may be 1 2 necessary, is hereby appropriated from the General Fund of the State to provide funds for 3 the New Legislature Building Complex Project. Section 2. Source of Funding. The funds appropriated herein shall be deemed to 4 have come from Chuuk State's share of the Grants from the Peoples Republic of China 5 which has been divided up equally amongst the five governments pursuant to the 6 Constitution, and approved in accordance with the relevant national law, in the amount of 7 \$500,000. 8 Section 3. Administration and Allotment of Funds. The sum appropriated under 9 Section 1 of this act shall be administered by and is allotted to Governor of Chuuk State 10 who shall be responsible to the Legislature to ensure that the funds are used only for the 11 purposes specified in Section 1, and in accordance with the State Financial Management 12 Act, and that no obligations are incurred in excess of the sum appropriated. The funds 13 shall remain available until fully expended. 14

15 Section 4. <u>Reporting</u>. The Allottee shall submit reports to the Legislature on or 16 before September 30, 2006, which shall:

Provide for the full disclosure of the obligations incurred against
the sum appropriated in this Act, and indicate the status of the funds as of September 30,
2006;

2. Provide any supplement report covering the actual uses,
obligations and expenditures of all the funds appropriated under this Act within 30 days
after the funds are fully expended.

ACT NO: 8-20

Section 5. Effective Date. This Act shall take effect upon its approval by the 2 Governor, or upon its becoming law without such approval.
