AN ACT

To amend Section 1. of Chuuk State Law No. 8-05-11. to reallocate and re-designate uses of funds appropriated herein for the purpose of funding State of Chuuk athletes participation in the upcoming Micro-Games to be held in Saipan, and for other purposes.

Be it enacted by the Chuuk State Legislature:

PA	Section 1. Amendment. Section 1, of Chuuk State Law No. 8-05-11 is hereby

7	deriving from Chuuk State Government investment in the Five Governments of

10	trustee. The sum or sums herein appropriated shall be allocated as follows,		
11	PROVIDED, that the funds herein shall remain available until fully expended and
