ACT NO: 8-31

AN ACT

To appropriate the sum of \$75,000.00 from the General Fund of the State as foreign grant fund received from the Government of the United States Department of Agriculture Rural Development Community Facility Grant for the purpose of purchasing certain equipment for the Department of Public Safety, and for other purposes.

Be it enacted by the Chuuk State Legislature:

1 Section 1. <u>Appropriation</u>. The sum of \$75,000.00, or so much thereof as may be 2 necessary, is hereby appropriated from the General Fund of Chuuk State which is to be 3 made available from grant fund received by the Government of the United States 4 Department of Agriculture Rural Development Community Facility Grant for the purpose 5 of funding the procurement of certain equipment for the Department of Public Safety.

6 Section 2. <u>Reporting.</u> The Director of the Department of Public Safety shall 7 submit a report, through the Governor, to the Legislature on or before October 15, 2007, 8 which shall indicate the actual expenditure of the fund used and unused as of September 9 30, 2007 from the proceeds of grant fund and the matched fund hereof the Director of the 10 Department of Public Safety shall be responsible to comply with the grant conditions and 11 other requirements for the implementation and uses of the grant fund authorized and 12 appropriated herein.

Section 3. <u>Effective Date.</u> This act shall become effective upon approval by the
Governor, or upon its otherwise becoming law without such approval.
