With privilege, I take this opportunity to advise the Legislature that I have reviewed and signed into law Legislative Act No. 8-34, entitled:

"To further amend C.S.L. No. 8-06-07, as amended by C.S.L. No. 8-06-15, by amending Sections 1, 2, 3, 5, 6, 8, 9, and 10 to supplement funding for the Office of the Governor, to reprogram and or reallocate certain funds and sources of fund necessary for the operation of certain departments, offices, bureaus, commissions, boards, and other programs and activities of the Executive Branch and for reporting on the status of funds, and for other purposes."

This Act has been designated as Chuuk State Law Number 8-06-16.

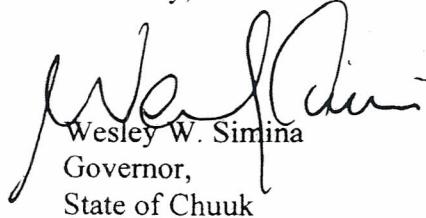

## AN ACT

To further amend C.S.L. No. 8-06-07, as amended by C.S.L. No. 8-06-15, by amending Sections 1, 2, 3, 5, 6, 8, 9 and 10 to supplement funding for the Office of the Governor, to reprogram and reallocate certain funds and sources of funds necessary for the operation of certain departments, offices, bureaus, commissions, boards and other programs and activities of the Executive Branch and for reporting on the status of funds, and for other purposes.

Be it enacted by the Chuuk State Legislature:

1       Section 1. Amendment. Section 1 of C.S.L. No. 8-06-07 is hereby amended to read as follows:

2           "Section 1. Budget for the State. There is hereby enacted a Chuuk State Budget  
3           for the internal operation of the Executive, Legislative, Judicial Branches of Chuuk  
4           State Government, State Public Auditor's Office, State Independent Prosecutors  
5           Office, State Boards, Commissions, Authorities, Agencies, Bureaus, Other Programs  
6           and Public Infrastructure Projects, pursuant to the authority vested in the Legislature by  
7           Article VIII, section 4 of the State Constitution.

8           a) Anticipated Revenues: The State anticipated the following revenues as  
9           projected and available for appropriation for the fiscal year ending September 30, 2007.

10           (1) Compact Sectorial Grants

19           b) Definition. When used in this act, the phrases:

20           (1) "Agency" mean any agency, commission, authority, board, bureau,  
21           or the organization of Chuuk State Government as established by law and not  
22           specifically part of one of the three branches of the Chuuk State Government.

23           (2) "Appropriation" refers to a law enacted by Chuuk State Legislature  
24           which authorized Chuuk State Government to incur obligations and to make

1 payment out of the Chuuk State Treasury in accordance with the Constitution  
2 the State of Chuuk.

3 (3) "Compact" refers to the Compact of Free Association, as amended,  
4 and its related agreements entered into between the Government of the  
5 Federated States of Micronesia and the Government of the United States and  
6 enacted as Untied States Public Law No. 108-188.

7 (4) "Department" refers to any departments and offices as prescribed  
8 in the Organization Act of 2004.

9 (5) "Fiscal Procedure Agreement" means the Agreement concerning  
10 Procedures for the implementation of the United State Economic Assistance  
11 provided in the Compact of Free Association, as amended, between the Government  
12 of the Federated States of Micronesia and the Government of the United States of  
13 America.

14 (6) "Fiscal Year" refers to each one-year period beginning October 1  
15 and ending on the next following September 30. Each Fiscal Year shall be  
16 designated by number of the calendar year in which such Fiscal Year ends.

17 (7) "Governor" means the Governor of Chuuk.

18 (8) "Internal operations" means the internal operations of the  
19 Executive, Legislative and Judicial Branches of the Chuuk State Government, the  
20 State Public Auditor's Office, the Independent Prosecutor's Office, State Boards,  
21 Commissions, Authorities, Agencies, Bureaus and other programs."

22 Section 2. Amendment. Section 2 of C.S.L. No. 8-06-07 is hereby amended to read as follows:

23 "Section 2. Authorization. The sum of \$37,149,677, or so much  
24 thereof, is authorized to be appropriated to fund the internal operations of the Chuuk  
25 State Government for the fiscal year ending September 30, 2007 provided, however that  
26 the amount authorized and appropriated may be adjusted by a later duly enacted  
27 statutes, if warranted by the State's economic and financial condition. The funds  
28 deriving from the Compact Sectorial Grants are herein authorized and appropriated  
29 subject to the conditions and requirements imposed on the uses and allocations of such  
30 fund or funds as prescribed by the Fiscal Procedure Agreement and such relevant Grant

1                   Awards."

2                   Section 3. Amendment. Section 3 of C.S.L. No. 8-06-07 is hereby amended to read as follows:

3                   "Section 3. Operating Expenses of the Executive Branch. The sum of  
 4                   \$21,017,941, or so much thereof as may be necessary, is hereby  
 5                   appropriated from the General Fund of the State for the fiscal year ending September  
 6                   30, 2007 for the purpose of funding the internal operations of the Executive Branch of  
 7                   the Chuuk State Government. The Governor shall be the allottee of these funds. These  
 8                   funds shall be apportioned as follows:
