AN ACT

To amend section 13 of Chuuk State Law No. 190-08 by amending the qualifications of the State Supreme Court Justices, and for other purposes.

Be it enacted by the Chuuk State Legislature:

1           Section 1. Amendment. Section 13 of Chuuk State Law No. 190-08 is hereby  
2 amended to read as follows:

3           "Section 13. Qualifications of the State Supreme Court Justices.

4           No person is eligible to serve as a State Supreme Court Justice unless he  
5 meets the requirements of Article VII, Section 9 of the Constitution and:


6           (1) is a graduate from an accredited law school in that jurisdiction;

7           and is admitted to the practice of law in any jurisdiction; or


8           (2) has at least 15 years experience in practicing law or service as a  
9 judge."

10          Section 2. Effective Date. This Act shall take effect upon approval by the  
11 Governor, or upon its becoming law without such approval.
