## AN ACT

To authorize and appropriate the sum of \$4,000,000 of funds from the General Fund of Chuuk State from the Special Grant for additional capitalization of CPUC and for the implementation of the Operation, Maintenance and Management (OMM) Program for CPUC and for other purposes.

Be it enacted by the Chuuk State Legislature:

1       Section 1. Appropriation and Authorization. There is hereby authorized for  
2       appropriation the sum of \$4,000,000 or so much thereof as may be necessary, is hereby  
3       appropriated from the General Fund of the State of Chuuk until fully expended or for the  
4       duration of the grant, for the purpose of providing additional capitalization of CPUC and  
5       implementation of the Operation, Maintenance and Management (OMM) Program for  
6       CPUC.

7       Section 2. Use of the Grant. The Grant shall be used exclusively for the following:  
8           1) Additional Capitalization of CPUC which shall not be more than \$1,700,000;  
9              and  
10           2) Implementation of the Operation, Maintenance and Management (OMM)  
11              Program for CPUC which shall not be more than \$2,300,000.

12       Section 3. Administration. The sum appropriated by Section 1 shall be  
13       administered by and is allotted to the Governor, or his designees, who shall be  
14       responsible to the Legislature and the grant donors to ensure that the funds are expended  
15       and implemented solely for the specific purpose, and conditions of which the grant was  
16       awarded and in accordance with the, Fiscal Procedures Agreement, State Financial  
17       Management Act and regulations, and that no obligations are incurred in excess of the  
18       sum appropriated. These funds shall remain available to be used and expended in  
19       accordance with terms and conditions of which it was issued, and with respect to grant  
20       expiration. An allottee shall only expend funds after the relevant advice of allotment for a  
21       grant award is received by the appropriate division in the Department of Administrative  
22       Services. PROVIDED, the allocation and specific uses of these funds shall be obligated  
23       and expended in accordance with the grants worksheets and awards.


1       Section 4. Reporting. The Governor, or his designees, shall submit a written  
2 report to the Legislature on or before September 30, 2012, which shall:

3           a) Provide for the full disclosure of the obligations incurred against the sum  
4 appropriated by Section 1 and indicated status of the funds as of September 30,  
5 2010, and

6           b) Indicate the planned use, of the remaining balance of the said funds, if there  
7 is any.

8       Section 5. Effective Date. This Act shall take effect upon approval by the  
9 Governor, or upon its becoming law without such approval.
