TENTH LEGISLATURE OF THE STATE OF CHUUK

SECOND REGULAR SESSION,
FIRST SPECIAL SESSION, OCTOBER, 2010

ACT NO: 10-31

AN ACT

To authorize and appropriate the sum of \$648,523 of funds from the General Fund of Chuuk State from the Special Infrastructure Grant for the implementation of the four projects specifically authorized by the Act, and for other purposes.

Be it enacted by the Chuuk State Legislature:

1 Section 1. Appropriation and Authorization. There is hereby authorized for
2 appropriation the sum of \$648,523, or so much thereof as may be necessary, is hereby
3 appropriated from the General Fund of the State of Chuuk until fully expended or for the
4 duration of the grant, for the purpose of providing funding to the following infrastructure
5 projects.

6 Section 2. Use of the Grant. The Grant shall be used exclusively for the
7 following infrastructure projects:

- 8 1) Southern Namoneas High School
- 9 2) Sapore Elementary School, and
- 10 3) Sapore Dispensary


11 Section 3. Administration. The sum appropriated by Section 1 shall be
12 administered by and is allotted to the Governor, or his designees, who shall be
13 responsible to the Legislature and the grant donors to ensure that the funds are expended
14 and implemented solely for the specific purpose and conditions of which the grant was
15 awarded and in accordance with the Fiscal Procedures Agreement, State Financial
16 Management Act and regulations and that no obligations are incurred in excess of the
17 sum appropriated. These funds shall remain available to be used and expended in
18 accordance with terms and conditions of which it was issued and with respect to grant
19 expiration. An allottee shall only expend funds after the relevant advice of allotment for
20 a grant award is received by the appropriate division in the Department of Administrative
21 Services, PROVIDED, the allocation and specific uses of these funds shall be obligated
22 and expended in accordance with the grants worksheets and awards.


1 Section 4. Reporting. The Governor or his designees, shall submit a written
2 report to the Legislature on or before September 30, 2012, which shall:

- 3 a) Provide for the full disclosure of the obligations incurred
4 against the sum appropriated by Section 1 and indicated status
5 of the funds as of September 30, 2010; and
6 b) Indicated the planned use of the remaining balance of the said
7 funds, if there is any.


8 Section 5. Effective Date. This Act shall take effect upon approval by the
9 Governor, or upon its becoming law without such approval.




